Vice-Chairman Hudgins noted a correction to the minutes stating the change of place for February 12 meeting, it should state the meeting to be held at the Board of Education Facility instead of the Courthouse Annex Building.

Motion by Hall seconded by Burgess to renew Concession Stand Agreement with Alice Temple for 2013 and to re-bid for 2014.

Chairman McCard state he would like to note that from his observation of the concession stand, he felt the County should take it back and operate it.

Motion by Calhoun seconded by Hudgins to advertise for bids for the Concession Stand at the Recreation facility and authorized Recreation Director Mike Coker run the concession stand until the Commissioners can get someone to operate the concession stand.

Motion by Calhoun seconded by Hudgins to approve the Emergency Medical Dispatching Program for the 911 Communications Department. County Manager Mary Wynn pointed out some minor changes to the Emergency Medical Dispatching Agreement before presented for signature by the Chairman.

Motion by Calhoun seconded by Hudgins to approve rate increase for the Emergency Medical Services as follows: Mileage Rate from current rate of \$10.00 per mile to \$13.00 per mile; Basic Life Support Non-Emergency Rate from \$375.00 o \$400.00; Advanced Life Support 1 Non-Emergency Rate from \$370.00 to \$450.00; Basic Life Support Emergency Base Rate, no change; Advanced Life Support 1 Emergency Base Rate from \$525.00 to \$575.00; Advanced Life Support 2 Emergency Base Rate from \$550.00 to \$600.00; and Specialty Care Transport Base Rate from \$630.00 to \$650.00. This is the first rate increase for emergency medical services since 2009.

Motion by Hudgins seconded by Hall to approve Consent Agenda as presented by Chairman McCard to include Budget Resolution # 2013-02-01 in the amount of \$63,000.00 for construction of the Emergency Medical Services building; # 2013-02-02 in the amount of \$8,124.00 for removing turf from a softball field and replacing with clay dirt at the Recreation Department; # 2013-02-03 in the amount of \$2,500.00 for Telephone Expense in the Executive Department for seven I-pads; # 2013-02-04 in the amount of \$23,000.00 for the Building Maintenance Department for mold remediation at the Turner County Health Department building; # 2013-02-05 in the amount of \$47,816.98 for General Fund Department salaries and social security expense for Christmas Bonus; Resolution # 2013-02-05.1 for the Drug Task Force Fund in the amount of \$641.08 for salaries and social security expense; # 2013-02-05.2 for the 911 Communications Department in the amount of \$4,371.70 for salaries and social security expense; # 2013-02-05.3 for Victims Assistance Fund in the amount of \$105.65 for salaries and social security expense.

Public Comments: Commissioner Hall expressed his disappointment that the Board of Commissioners did not allow Alice Temple to operate the concession stand at the Recreation Department for another year stating this will put her out of business.

Rosemary Hall spoke stating she did not know of any problems with the way Alice Temple had operated the concession stand at the Recreation Department and stated the concession stand was her livelihood and felt this should not have been taken from her.

Ronnie Buchanan spoke stating he did not feel the County should allow Mike Coker, Recreation Director to run the concession stand.

Alice Temple spoke stating Commissioner Hudgins had put something in the paper that had hurt her family and did not know the facts and felt it was unfair to her and her family. She further state that in October 2010 she was out of town and a tournament was held and she had not been notified about the tournament and the County allowed someone else to come in and run the concession stand. Chairman McCard intervened in the conversation stating he would not allow a debate on the subject and called for a close in the conversation about the concession stand.
