Motion by Commissioner Calhoun seconded Commissioner Hudgins to let Robby Royal write specifications and receive bids for a new warehouse for fire/rescue equipment, motion passed, with Commissioner Calhoun, Hudgins and McCard all voting in favor of the motion. Commissioner Burgess and Commissioner Hall opposed the motion.

Motion by Commissioner Hall seconded by Commissioner Calhoun to authorize Turner County Connections to apply for the Georgia Rural Health Network Grant and authorize the Chairman to sign the grant with the approval of our County Attorney, motion passed, with Commissioner Burgess, Calhoun, Hall, Hudgins and McCard all voting in favor of the motion. *Report:*

Sheriff Andy Hester spoke stating he would like for the Commissioners to sit down with him to discuss additions to the Sheriff Office to include more office and storage space. If see fit, then put 911 there too. It will be more secure and help his operation flow better.
