**Bethel Road** – Statewide Engineers reported that water is under pavement on Bethel Road and will need some drain tile installed. He stated they would get cost estimates for this because this was not in the initial scope of work.

**Risk Management Inspection** – Ms. Natalie Sellers, Field Representative with the ACCG Risk Management Services performed an inspection of the County's Safety Program on January 26, 2015 and listed three (3) recommendations in her report back to the County. Two of the recommendations have been corrected already and the third is to run motor vehicle checks on existing employees every three years, which we will be implementing. Overall, she felt we are "doing a fantastic job" in our safety program. Mike Mastrario is the County's Safety Coordinator.

**Recreation** – The new roof on the Concession Stand is complete and looks very good. Mr. Holley commented that going to the heavier grade of metal should last for a long time. Also, we have more participation in basketball this year from last year, a twenty percent (20%) increase.

**Elections Department** – This month we are highlighting our Elections Department and have Ms. Janet Winter, Elections Supervisor tell us about the Elections Department. Ms. Winter gave a brief overview of duties and responsibilities of her department.
