

The Turner County Board of Commissioners met on Tuesday, June 30, 2015 at 6:00 P.M. at the Agricultural Center for the Monthly Work Session Meeting with Commissioners Burgess, Calhoun, Denham, Hall and McCard present for the meeting. Staff present were Mary J. Wynn, County Manager, Latrice Wilson, County Clerk and John Holland, County Attorney. Others present were Mike Coker, Recreation Director, Ben Baker, Editor of the Wiregrass Farmer, Sheriff Andy Hester, Janet Winter, Elections Superintendent, Lynn Davis, Extension Service Coordinator, Will Gay, Ag Agent and Jason Lawson, E-911-EMA Director.

Chairman McCard called the meeting to order at 6:00 P.M.

Commissioner Hall gave the invocation.

Motion by Commissioner Calhoun seconded by Commissioner Denham to adopt Budget Resolution # 2015-06-01 approving Fiscal Year 2015-2016 budgets as follows: General Fund - \$7,900,000.00; Special Purpose Local Option Sales Tax Fund (2006 Issue) - \$5,000.00; Special Purpose Local Option Sales Tax Fund (2012 Issue) - \$850,100.00; Jail Special Revenue Fund - \$350,100.00; Drug Education Special Revenue Fund - \$27,010.00; Solid Waste Fund - \$275,000.00; Victims Assistance Special Revenue Fund - \$195,200.00; E-911 Special Revenue Fund - \$524,410.00; Real Estate Deed Index Project Special Revenue Fund - \$ 18,030.00; Solid Waste (Deposit) Special Revenue Fund - \$11,000.00; Hotel/Motel Tax Special Revenue Fund - \$2,800.00; Sheriff's Drug Enforcement Special Revenue Fund - \$60,020.00, and Local Maintenance Improvement Grant (LMIG) Special Revenue Fund - \$417,799.00 and authorize Chairman McCard to sign resolution on behalf of the County, motion passed with Commissioners Calhoun, Denham and McCard voting in favor of the motion. Commissioners Burgess and Hall opposed the motion.

Commissioners discussed the Turner County Five Year Hazard Mitigation Plan Update Application for FEMA Grant Funding.

Commissioners discussed budget amendments for FY 2014-2015.

Lynn Davis introduced the new Ag Agent, Will Gay. Mr. Gay gave a brief statement of his background and his position as the new Ag Agent.

County Manager Mary Wynn gave her County Manager's Report.
