

The Turner County Board of Commissioners met on Tuesday, March 28, 2017 at 6:04 p.m. at the Turner County Agricultural Center with Commissioners Burgess, Calhoun, Denham and Hall present for the meeting. Commissioner McCard was not present. Staff present were Horace Hudgins, Interim County Manager, Latrice Wilson, County Clerk and John Holland, County Attorney. Others present were Josh Martenn, Brent Rucker, Road Superintendent, Mark Robinson, Fire Chief/EMA Director, Ben Baker, Editor of the Wiregrass Farmer, Janet Winter, Elections Superintendent, Mike Mastrario, Building and Zoning Inspector and Velvet Riggins, Recreation Director.

Commissioners discussed board appointment to serve on the Region 4 Advisory Council-Mental Health Board to represent Turner County for a three year term.

Commissioners discussed appointment for Mrs. Janet Winter to serve as Turner County Election Supervisor/Chief Registrar for a four year term beginning July 1, 2017 ending June 30, 2021.

Commissioners discussed appointing a licensed physician or licensed nurse to serve on the Turner County Board of Health for a six year term.

Commissioners discussed reappointment of Mr. Sonny Walker to the Turner County Board of Family and Children Services for a five year term.

Commissioners discussed Drug and Alcohol Testing Policy for Turner County Transit (5311 Program).

Commissioners discussed 2017 Safety Action Road Project Application for Turner County to do striping and raised pavement markers.

Motion by Commissioner Calhoun seconded by Commissioner Burgess to approve application for Turner County Hazard Mitigation Plan Update, motion passed with Commissioners Burgess, Calhoun, Denham and McCard voting in favor of the vote.

Velvet Riggins, Recreation Director gave a brief update on the Recreation Department.
