

The Turner County Board of Commissioners met on Tuesday, March 26, 2019 at 6:00 p.m. at the Turner County Agricultural Center for the monthly Work Session with Commissioners Burgess, Calhoun, Denham and Commissioner Hall (by telephone) were present.
