Motion by Commissioner Calhoun seconded by Commissioner Hall to approve Executive Session Minutes for Tuesday, September 29, 2020, motion passed with Commissioners Calhoun, Denham, Hall and McCard voting in favor of the motion.

Motion by Commissioner McCard seconded by Commissioner Calhoun to go into Executive Session at 6:21 p.m. for the purpose of real estate, motion passed with Commissioners Calhoun, Denham, Hall and McCard voting in favor of the motion.

Motion by Commissioner Calhoun seconded by Commissioner Hall to end the closed session and return to the regular meeting at 6:28 p.m., motion passed with Commissioners Calhoun, Denham, Hall and McCard voting in favor of the motion.
