

The Turner County Board of Commissioners met on Tuesday, June 30, 2020 at 6:00 p.m. at the Turner County Agricultural Center for a called “advertised” meeting and work session with Commissioners Burgess and Denham present. Commissioners Hall and McCard present by ZOOM. Commissioner Calhoun was not present. Staff present were Joseph Saxon, County Manager and Latrice Wilson, County Clerk. County Attorney, John Holland was present by ZOOM. Others present were Dustin Beaty, Road Superintendent, Sheriff Andy Hester, Chief Deputy Charles Dean, Janet Winter, Elections Superintendent, Lynn Davis, Extension Coordinator and Ben Baker, Editor of the Wiregrass Farmer.

Chairman Denham called the meeting to order at 6:00 p.m.

Mr. Ben Baker gave the invocation.

Commissioners presented a proclamation designating the Month of July as Park and Recreation Month.

Motion by Commissioner Hall seconded by Commissioner Burgess to adopt Budget Resolution #2020-06-02 approving fiscal year 2020-2021 budgets as follows: General Fund-\$8,744,623.00, E-911 Special Revenue Fund - \$626,026.00, Drug Education Special Revenue Fund - \$22,000.00, Hotel/Motel Special Revenue Fund - \$500.00, Sheriff’s Drug Enforcement Special Revenue Fund - \$30,020.00, Real Estate Deed Index Special Revenue Fund - \$10,030.00, Victims Assistance Special Revenue Fund -\$190,200.00, Jail Special Revenue Fund -\$360,000.00, Solid Waste Special Revenue Fund -\$265,000.00, Solid Waste Deposit -\$600.00, Law Library Special Revenue Fund -\$1,000.00, Special Purpose Local Option Sales Tax (2018-2024) Special Revenue Fund -\$901,400.00, Local Maintenance Improvement Grant (LMIG) Special Revenue Fund -\$484,000.00, Transportation Special Local Option Sales Tax Special Revenue Fund - \$360,000.00 and Community Development Block Grant (CDBG) Special Revenue Fund - \$545,265.00 and authorize the Chairman to sign resolution on behalf of the County, motion passed with Commissioners Burgess, Denham, Hall and McCard voting in favor of the motion.

Motion by Commissioner Hall seconded by Commissioner McCard to award bid for Janitorial Services for Turner County to Tammy Pate, LLC for 3-days cleaning in the amount of \$31, 000.00, motion passed with Commissioners Denham, Hall and McCard voting in favor of the motion. Commissioner Burgess opposed the motion.

Motion by Commissioner McCard seconded by Commissioner Hall to approve providing medical insurance for the Chamber Director on County’s insurance, motion passed with Commissioners Denham, Hall and McCard voting in favor of the motion. Commissioner Burgess opposed the motion.

Motion by Commissioner Hall seconded by Commissioner Burgess to approve contract with Best Friends Humane Society for animal control for Turner County and authorized the Chairman to sign contract on behalf of the County, motion passed with Commissioners Burgess, Denham, Hall and McCard voting in favor of the motion.

Commissioners table General Discussion, Item # 1, Discuss Airport Project until more information is provided by GDOT.

Motion by Commissioner Burgess seconded by Commissioner Denham to go into closed session at 6:10 p.m. for the purpose of discussing real estate, motion passed with Commissioners Burgess, Denham, Hall and McCard voting in favor of the motion.

Motion by Commissioner Burgess seconded by Commissioner Hall to return to the regular meeting at 6:19 p.m., motion passed with Commissioners Burgess, Denham, Hall and McCard voting in favor of the motion.

The meeting adjourned at 6:20 p.m.
